

EXTRACT OF DECISIONS TAKEN AT THE 101TH MEETING OF SENATE HELD WEDNESDAY, 23RD DECEMBER, 2020/ 8 JUMĀDĀ-L-‘ŪLĀ 1442 AH IN THE SENATE CHAMBER

The Senate at its 101th meeting held on Wednesday, 23 December 2022 considered the results of 2019/2020 Summer / Make-up examinations, requests and application from students on academic and other related matters. After careful and extensive deliberations, Senate took the following decisions:

1.0 Consideration of the 2019/2020 Summer / Make Up Examination Results

i. Upgrade of Scores:

Senate considered and approved the request for upgrading of scores of the following students:

- a. **BAMIJI**, Nadiyah Folasade (FUO/16/0107) -400 level Microbiology upgrade MIB 414 from 61(B) to 70(A)
- b. **ONAKOYA**, Oyindamola Wuraola (FUO/16/0202) - 400 level Mass Communication to upgrade MCM 205 - 51(C) to 60 (B).

ii. Request for Waiver

The Ag. Dean, Student Affairs to follow up with Vice Chancellor's Office on the request for a waiver of two (2) sessions by **ABDUL-AZEEZ**, Shukurah (MAS/15005) – 400 level Economics to enable her graduate. Bursar to be copied.

iii. Pass list for the Nursing Science

- a. Students with CGPA of 2.40 and above with no outstanding course to be on **the Clear Pass List**.
- b. Candidates with CGPA of 2.40 and above with one or two outstanding course(s) be placed on **Probation and allowed to clear all outstanding course(s)** in the next academic session (2020/2021)

iv. Senate noted that **IBRAHIM** Muhammed (FUO/18/0152) - 200 level Political Science has 0.60 CGPA owing to his inability to write the second semester (on line examination). His parent could not afford to get him a phone to join the on-line lectures due to their financial constraints, a situation that led to his inability to write the second semester online examinations and the computed results with a CGPA of 0.06. His parents were advised to write the Vice Chancellor, seeking his magnanimity for their son be allowed to retake all the missed courses instead of withdrawing from the University.

Senate resolved that he should be listed as 'Not Registered' instead of 'Withdrawal'. By implication, he will have an opportunity to retake the second semester and have an extra year.

2.0: 2020/2021 Academic Calendar:

Senate upheld the Amended Calendar indicating that the 2020/2021 Academic Session commence on Sunday 3rd January, 2021. The Committees on Physical Resumption and Health to work modalities for strict compliance with all directives on COVID-19 protocols and submit details to Vice Chancellor by Wednesday, 30th December, 2020.

3.0 Approval of the proposed name for College

The name, College of Basic Medical and Health Sciences was adopted as contained in the New Academic Brief.

4.0 Request for approval on change of programme name from B.Sc. Banking & Finance to B.Sc. Finance

Senate approved the request. The Academic Planning Unit to forward all necessary documents in this regard to the National Universities Commission by 11th of January, 2021 and report back at the next Senate meeting in January 2021.

5.0 Consideration of the curricula for the B.Sc. Public Administration and M.Sc. Political Science

Senate approved the curricula for the B.Sc. Public Administration and M.Sc. Political Science programmes. It directed the Academic Planning Unit to forward all necessary documents in this regard to the NUC by Wednesday, 11th of January 2021 and report back at the next Senate meeting in January 2021.

Senate also answered the prayer from the Department that the previous decision on the nomenclature of the programme on the certificates be reviewed and what appeared in the Academic Brief from the inception (Political Science & Public Admin) be adopted. The University should tarry till coming of the NUC. The Deputy Registrar, (VC's office) was directed to handle this.

6.0 Consideration of the Curricula for the M.Sc. Accounting and M.Sc. Finance

Senate approved the curricula for the two programmes and directed the Academic Planning Unit to forward all necessary documents in this regard to the NUC by 11th of January, 2020 and report back at the next Senate meeting in January 2021.

7.0 Confirmation of studentship Status of OJO, Toluwalase Michael (MAS/15128) 400 level Accounting

Senate noted that the studentship of OJO, Toluwalase had lapsed as he did not register for his outstanding courses in 2019/2020 session. He should be allowed to continue if he applies in subsequent sessions upon fulfilment of necessary conditions for reabsorption.

Senate also directed that henceforth, students with similar cases should be considered on their own merit.

8.0 Re: Students with no evidence of Registration– ABII Anita Chieloma (200 level Economics) & USMAN Damilola Babatunde (200 level Economics)

Senate noted that the above two students did not register and that they were considered to have voluntarily withdrawn from the University. The Registry to communicate this to their parents/guardians and report back to Senate at the next meeting.

9.0 Proposal for Award of Honorary Doctorate (Honoris Causa)

Senate approved the award of Honorary Doctorate Degree (*honoris causa*) to Dr. AWA Ibrahim, Doctor of Business Administration – DBA, Professor Nurudeen ‘Nimbe Adedipe, Doctor of Science – DSA and Prof. Toyin Falola, Doctor of Public Administration – DPA but advised that the conferment be deferred until the 2022 Convocation when physical ceremony could hold.

10.0 Preparation for the 10th Convocation Ceremony

Senate resolved that the 10th Convocation ceremony be shifted to allow for a befitting and seamless convocation. A shift of about three (3) months in 2021 or a combined event for 10th & 11th convocation ceremonies in 2022 should be proposed to the Council and copied to the Board of Trustees.

Upon approval, Senate recommended that:

- i. a Hybrid instead of Virtual be adopted to enable graduating students in Osogbo area attend physically if they so wish,
- ii. Graduating students who may wish to attend physically to be allowed to come with ONLY TWO GUESTS,
- iii. Members of NASFAT, friends of the University and the general public should join the ceremony online, and

- iv. To ensure compliance with the COVID-19 Protocol, some canopies be erected outside the Amina Namadi Sambo Hall.

11.0 Amendment to 2019/2020 Second Semester Examination Result – 400 level Computer Science

The amended result was approved as presented.


