

EXTRACT OF DECISIONS TAKEN AT THE 107TH MEETING OF SENATE HELD TUESDAY, 15TH JUNE, 2021/ 4 DHUL- QA'DAH 1442 AH IN THE SENATE CHAMBER

The Senate at its 107th meeting held on Tuesday, 15 June 2021 deliberated on a number of issues and took the following decisions:

1.0 Consideration of the 2020/2021 First Semester Examination Results

i. Resumption of Studies:

Applications to resume studies will no longer be considered by Senate until these conditions are met:

- a. Letter of approval to suspend studies,
- b. Academic profile, and
- c. Financial profile.

2.0. Confirmation of the Number of Students who sit for Examinations

The ICT unit to always make available at Senate the number of students registered for each course whenever the results are being considered at Senate.

3.0. Forwarding of Examination Results to Senate Members

Soft copies of Senate approved examination results should herceforth be sent to members of Senate.

4.0. Consideration 1st Semester Results:

The 1st Semester results presented by the Chairman, BCOS were approved with the following amendments:

4.0.1. Biochemistry- Results approved as presented but Student with serial number 1

of 400 Level BCH, ALAFGRITI, Tunde (FUO/17/0102) to be listed under Expulsion List and not Determination of Studentship.

4.0.2. Business Administration

The HoD should liaise with the ICT unit so as to account for two students that were missed out on the spread sheet of result in 300 level.

4.0.3 Economics

HOD Economics to account for candidate with serial number 1, OYETUNJI, Olufemi (FUO/18/0201) 300 Level Economics with a CGP of 0.81 on Determination of Studentship (DOS) owing to his absence in the school. The HoD to forward a report on the situation to the Registrar by 20th June 2021.

4.0.4. Computer Science

- i. Result of AL-MARUF, Umar Faruk (FUO/19/0112) 200 Level was stepped down until the student presents the Approval to submit 2019/2020 second semester examination's scripts for assessment and grading.
- ii. Result of ADESHINA, Mukaila (FUO/18/0001) 300 level was stepped down until the student presents the Approval to submit 2019/2020 second semester examination's scripts for assessment and grading.

4.0.5. Mass Communication

The HoD to account for EFUWAPE, Ayodeji, 200 Level who is on Not Registered List.

4.0.6. Students Admitted after March 15 2021

Fresh Students registered after 15 March, 2021 and have not met the 70% attendance to be eligible to write the 1st Semester Examinations are to be given an opportunity to write their First Semester examinations during the Summer Belt.

4.0.7. Upload of 2019/2020 Examination Results

Heads of the Departments who have not uploaded the 2019/2020 Examination Results are to do so latest by 16 June 2021.

4.0.8. Result Computation

Senate adopted the directive of the NUC that Nigerian Universities should revert to the **five-point scale** (which incorporates a pass degree) hitherto in use with effect from the 2018/2019 academic session.

5.0.0. Report of the Committee on Charges / Dues Paid by Students

Senate approved the recommendations of the Committee on streamlining of charges and dues paid by students.

Amount to be charged as Dues to be decided by students subject to approval of the management. The Dean of students to communicate this to all stakeholders.

All charges and dues are to be paid into dedicated/verifiable accounts and students signatories to such accounts to be selected by students without undue interference.

The Bursar is to facilitate account opening where there is none.

Change of signatories to accounts and proper handing over to be a condition for clearance of concerned students at the end of their tenure/studies.

Recommended books are to be approved by departments before they can be sold to students.

6.0.0 Applications by Students

a. Re: Appeal by GIWA, Munirat Damilola (FUO/18.0159) 300 level Bus. Admin against suspension was turned down by the Pro-Chancellor on behalf of Council.

b. Re: Mix-Up of Letter of Suspension of Studies – ADEOLA, Aliu Omowunmi (FUO/16/0083) 400 level Political Science.
Senate directed that the student should attach her academic and financial profile to the letter before she can be considered.

7.0.0. Report on Drug Test

The list of students who did not collect their test results but wrote the examinations to be made available by the Registrar by 27th June 2021.

Timetable for drug screening in 2020/2021 session to be made available.

The results of the drug test, positive or negative to be communicated to parents/guardians.

Students who test positive to illicit drug to be warned at the first instance, a positive result after the second screening will attract expulsion.

8.0.0. Report on ENT 301 Course

ENT 301 is a compulsory course for all students in the third year of their degree programmes. It should be so indicated against students who fail to register for it. They must be made to take it at the next available opportunity.

9.0.0 Report from Postgraduate School

The Senate considered the report from the Dean, PG School and directed that:

- a. Money for NUC resource verification visit be paid by Wednesday 16th June, 2021,
- b. Necessary facilities should be put in place to ensure a successful visit,
- c. The Dean, PG to ensure that all necessary documents regarding MBA, MSc. Sociology, PGD in Management are ready for the NUC visit, and

- d. HoD Mass Communication to present at the next Senate the Curriculum for MSc. Mass Communication.


