# EXTRACT OF DECISIONS TAKEN AT THE $108^{\rm TH}$ MEETING OF SENATE HELD TUESDAY, $6^{\rm TH}$ JULY, 2021/ 26 DHUL- QA'DAH 1442 AH IN THE SENATE CHAMBER



The Senate at its 108<sup>th</sup> meeting held on Tuesday, 6 July 2021 deliberated on a number of issues and took the following decisions:

## 1.0 Ratification of Deputy Vice Chancellor (DVC) nomination

Section 4 (1-4) of the University Law provides that, the Deputy Vice-Chancellor shall be appointed by the Council on the nomination of the Vice-Chancellor and recommendation of Senate.

In an open election conducted for the above purpose, Professor A. T. Lawal secured 10 votes against Professor Goke Lalude's 7. Professor Lawal was voted and recommended to Council for approval.

## 2.0 Replacement of Dr. A. K. Salau as Senate representative on Council

Dr. S. O. Jimoh was elected to replace Dr. A.K. Salau as Senate representative on the Governing Council. She is to replace and serve out the term of Dr. A.K. Salau who disengaged from the services of the University.

#### 3.0 New 100L Students admitted after March 16 2021

Senate reiterated its decision at 107 Senate meeting of (Tuesday, 15<sup>TH</sup> June, 2021) that new students who registered after the 15<sup>th</sup> of March 2021 qualify to write the 2020/2021 First semester exams during 2021 summer belt at no extra cost. ICT to provide lists of affected students to Departments, Registry, and VC Office. Should any student in this category have illegally written any examinations, results are to be discountenanced at Senate if presented.
