

EXTRACT OF DECISIONS TAKEN AT THE 110TH MEETING OF SENATE HELD TUESDAY, 22ND SEPTEMBER, 2021/ 11 SAFAR 1443 AH IN THE SENATE CHAMBER

The Senate at its 110th meeting held on Wednesday, 3 September, 2021 deliberated on a number of issues and took the following decisions:

1.0 Consideration of the 2020/2021 Second Semester Examination Results

Senate approved the Second Semester results presented by the Chairman of the Business Committee of Senate. The existing in-house software was used for the computation of results for 100 & 200 levels while the Reskit was used for the 300 & 400 levels.

Senate also took the following decisions with regards to the approval of results:

i. Computation of Result for Students admitted after 15 March, 2021

Senate reaffirmed its earlier decision to discountenance the results of newly admitted students who registered after 15th of March, 2021 but still wrote the First Semester 2020/2021 examinations.

The Secretariat to inform such students to write the First Semester examinations during the summer belt.

ii. 100 level Mass Communication

The HoD is to liaise with the ICT to resolve the issue with the online registration of ABUBAKAR, Hamama (FUO/20/0514)

iv. 100 level Computer Science

PCSO in the summary page should be changed to read PCSO as shown in the RESKIT Package.

v. 200 level MLS

HOD should advise candidate on serial number 7 (FUO/20/0226) with seven (7) carry over courses to either repeat the class or look for another related course where he can perform better.

vi. 200 level Nursing

Students with more than two (2) outstanding courses are to either repeat the class or move to a related programme.

vii. 400 level Economics

Senate granted the prayer of the HoD to waive ECO 312 outstanding against the student with matric number 14/FUO/17/0273) and ECO 411 for student with Matric Number 18/FUO/18/0304. Their results are to be computed and presented during the consideration of Summer Results.

5.0 AOB

a. 2020/2021 Summer Programme

Senate reaffirmed that:

- i. Maximum of 6 courses was approved to be taken by a student during the summer.
- ii. Only 300 and 400 levels students are qualified to write summer.
- iii. Students who have spent six academic years and who have met the minimum required number of credit units are allowed to take all their outstanding courses with pay during summer.
- iv. Nursing and MLS students are allowed to take a maximum of two (2) core courses at all levels subject to payment of the prescribed sum for the summer programme.
- v. Students who failed more than two core courses will repeat the class or change to other programmes.
- vi. Non- core courses failed must be retaken and passed before graduation.

b. Attendance of Senate Meetings by Sub-Deans

Registrar was requested to confirm if Sub-Deans were qualified to attend meetings of Senate so that invitation can henceforth be extended to them.


c. Remuneration for staff who are to teach second semester admitted students

Senate considered that there should be motivation (financial or otherwise) for staff who render extra services to the university as at when due.

Senate was informed that the Vice Chancellor has approved that all lecturers should proceed on leave immediately after the summer programme. They will resume at the beginning of the first semester of 2021/2022 academic session.


d. Compliance with the Dress Code
