



EXTRACT OF DECISIONS TAKEN AT THE 111TH MEETING OF SENATE HELD ON FRIDAY, 22ND OCTOBER, 2021/ 15 RABI'UL AWWAL 1443 AH IN THE SENATE CHAMBER

The Senate at its 111th meeting held on Friday, 22nd October, 2021 deliberated on a number of issues and took the following decisions:

1.0 Request for consideration of Results -100 & 200 levels Nursing

Senate approved the request for consideration of 100 & 200 levels Nursing results to take care of MIB 102 and NSC 299 (Clinical Training) both as 3-unit course each.

2.0 Request for consideration of Results -100 level Public Health

Senate approved the request for consideration of 100 level Public Health result to take care of MIB 102 as 3-unit course.

3.0 Amendment to 2020/2021 First Semester Result – 400 level Physics with Electronics

Senate approved the amended 2020/2021 First Semester examination's result for 400 level Physics with Electronics.

4.0 Consideration of the 2020/2021 Summer / Make-Up Examination Results

Senate considered the 2020-2021 Summer and Make-up Examinations and noted that:

i. New Result Package

The new result package did not reflect courses of students in the Nursing programme with percentage as pass-mark. Mr. A. Akinlabi to help resolve this issue as it affect their passed and outstanding courses.

ii. 400 level Economics

ADESHINA, Tawakalitu (FUO/17/0059) Economics Department registered 10 courses in the summer. Senate directed that only five (5) courses should be recorded for her while the sum of N250,000 paid for additional five (5) courses to be transferred for payment of her school fees in 2021-2022 session.

iii. Granting of Waiver on outstanding courses

Waivers can only be granted on "Elective courses" provided such student has met the graduation requirements.

iv. 400 level Mass Communication

Candidate on serial number 1 of the summary page, ADESHINA, Fuad (NAS/15015) registered and took 15 courses in summer. Senate directed that his result be stepped down.

v. **Wrong Computation of Result**

The ICT Committee at look the reason for the wrong computation of CGPA for 200 level MLS students that were admitted in the second semester.

vi. **300 level Accounting**

The result was approved subject to correction of error in the result computed for candidate on serial number 5.

v. **200 level Public Health**

HoD should check on candidates with two only names to know if she has a third name.

vi. **300 level Environmental Health Sciences**

GPA but not CGPA are what are available at end of the first semester. It only becomes a CGPA at the end of the second semester.

vii. **100 & 200 levels Medical Laboratory Science**

The results were stepped down till availability of the summary page.

vii. **400 Microbiology**

The result was stepped down.

d. Orderliness of Senate


Members were urged to conduct themselves with decorum during Senate proceedings.

GNS unit should be completely detached from the College of Management and Social Sciences. In addition, Senate advised that GNS examinations should henceforth be conducted through the CBT.


f. Power Infrastructure
