EXTRACT OF DECISIONS TAKEN AT THE 119TH MEETING OF SENATE HELD ON TUESDAY, 19 JULY 2022/20 DHUL-QA'DAH 1443 AH IN THE SENATE CHAMBER

Senate, at its 119th meeting held on Tuesday, 19 July 2022, deliberated on many issues and took the following decisions:



1.0; Update on MIT & HARVARD Online Courses

Senate urged the Dean, COLAW, to encourage her HoDs to submit, without further delay, a list of chosen courses from the available MIT & Harvard online courses and forward to Curriculum Committee by 10 August 2022.

2.0: Proficiency in Qur'anic/Arabic

Senate directed that the Committee on Interface with NASFAT Mission Board should present the modified form of MoU as approved to NASFAT Mission Board for concurrence and signature.

3.0: 2022 Annual Report

Senate urged all departments that are yet to comply to do so on or before Monday, 2nd August 2022 and submit to the Academic Planning Officer, Mr. I. Bisiriyu.

4.0: Preparation for the 2022 NUC Programme Accreditation

Senate directed that all departments due for re(accreditation) should send their requirements to the VC before the next Senate meeting in August.

5.0: Need for Engagement of Professional Counsellor

Senate reiterates the need to engage a female professional Counsellor for students.

6.0: Report of Committee on the 2021/2022 First Semester Examinations

Senate adopted the report of the examination monitoring committee for the 2021/2022 First Semester examinations and directed that the shortcomings noticed should be adequately addressed before the second semester examinations.

7.0: Registration on Google Scholar

Senate directed academic staff who are yet to comply to do the needful before 10th August 2022 and convey links to ICT for transmission to the VC's office by 12 August 2022.

8.0: Preparation for the 2021/2022 Second Semester Examinations

After careful and extensive deliberations, Senate resolved as follows:

(i) That the date of commencement of end-of-semester examinations be postponed by two (2) weeks; one week for lecture and one (1) for revision and pre-examination workshops for students and staff.

- (ii) The second-semester examinations will now commence on Friday, 5 August and end on Friday, 20 August 2022.
- (iii) The Health Committee should ensure clearance of all eligible students for Drug Tests on or before Friday, 22 July 2022.
- (iv) All College Officers to submit their requisition for examination materials through their respective Deans for the approval of the Vice-Chancellor.
- (v) All Staff members, including the Examiners/Invigilators, must lead by example by ensuring that they wear their VALID Identification cards at all times, especially at venues of examinations.
- (vi) Registry should ensure that all students get their Identification cards before the commencement of the second semester examinations.
- (vii) The Director of Works & Physical Planning to ensure the following:
- a. Provision of electricity throughout examinations
- b. All the examination venues are well kept, clean and adequately lit.
- Wall clocks are provided in most examination venues, especially where this item is missing
- (viii) The College, through their respective College Officers, should submit to the Academic Planning Unit their requests for funds for the provision of refreshments for examiners/invigilators. The Academic Planning unit is to submit a global request to the office of the Vice-Chancellor.
- (ix) The Academic planning Unit shall convey the revised academic calendar as amended to the office of the Vice-Chancellor on or before Monday, 25 July 2022.

9.0: APER form for the 2021/2022 Annual Appraisal & Promotion Exercise

The boards of respective colleges were urged to expedite action on completed APER forms and forward their recommendations to the Registry for further processing on or before 12 August 2022.

10.0: 2022 ADAPTI Training

Senate urged management to sustain the tempo by ensuring that training & re-training of staff is of top priority.

11.0: Committee on Drug Test

Senate directed that the Committee on Drug Test should ensure clearance of all eligible students on the portal on or before Friday, 29 July 2022.

13.0: ENT 302 (Entrepreneurship and Skills Acquisition)

Senate approved the recommendation from the Coordinator, Centre for Entrepreneurship Studies for waiver of ENT 302 (Entrepreneurship and skills acquisition) from the second semester 2021/2022 examinations.

14.0: Celebration of Recognized International Heath Days

Senate resolved that the proposal be stepped down given ambiguities noticed in it.

15.0: Report of Committee on Central Research

Senate adopted the report and urged members to peruse it and send their observations/inputs to the Chairman of the Committee.

16.0: Report of the Student Disciplinary Committee

Senate upheld the recommendations of SDC that ADEKANYE, Kabirat Folashade (FUO/18/0010) & ALATISE, Fasilat Nike (FUO/19/0184) both 400L students in the Department of Mass Communication to undergo a Two (2) week community service effective from Thursday, 21 July 2022 on account of an assault on a fellow student.
