#### DECISION EXTRACT

Senate at its 78<sup>th</sup> meeting held on 20<sup>th</sup> March, 2018 deliberated extensively on many issues and the following decisions were taken:

#### 1. YEAR 2017 PROMOTION EXERCISE

The Chairman informed Senate that the staff due for 2017 promotion was presented to the Council at its meeting of 15<sup>th</sup> March, 2018. After careful perusal of the report, Council returned the report for the input of the newly appointed Vice-Chancellor after which executive approval may be granted for implementation.

#### 2. UPDATE ON PROPOSED SCHOOL FEES INCREMENT

The Chairman informed Senate that Council at its meeting of 15<sup>th</sup> March, 2018 directed Management to suspend the increment in school fees for now.

#### 3. EXAMINATION TIME TABLE

The Senate noted that the 12 days as approved by it was spent in the writing of the 2017/2018 first semester examinations. Senate also approved that consideration of examination results by Senate should come up 4 weeks after the writing of the last paper and should be included in the examination time table for subsequent examinations.

#### 4. INSTITUTIONAL ACCREDITATION

Senate directed that the Committee set up by Senate for Mock Accreditation should obtain from the Directorate of Academic Planning all necessary materials and documents needed for the Institutional Accreditation and present to Senate within 2 weeks (3<sup>rd</sup> April, 2018) the modalities by which Mock Institutional Accreditation could be carried out

### 5. REPORT OF THE STUDENT DISCIPLINARY COMMITTEE

Arising from this 23<sup>rd</sup> December of every year to the 2<sup>nd</sup> January of the following year have been declared semester break for both staff and students to enjoy the Christmas and New Year.

#### 6. FIOH AND ENTREPRENEURSHIP

The Chairman directed that the Committee set up to look into this should liaise with tertiary institutions where the practice is already in place in order to be able to come up with a comprehensive report and implementation in 2017/2018 academic session. Senate was informed that the fiqh was already incorporated in the syllabus of the University. Senate observed the need to review the GNS courses which would be handled by a Committee to be put in place.

#### 7. DEFERMENT/SUSPENSION OF STUDENTSHIP

Senate noted the requests from students on deferment and suspension of studentship and was unable to decide conclusively on whether such students should pay school fees during their deferment/suspension period. Arising from this a Committee was set up to look into this and report to Senate at its next meeting. The Committee is made up of

#### 8. PROPOSAL ON POLICY ISSUES ON RESULT COMPUTATION

Senate noted the paper and directed that at the conclusion of each semester examinations every department must have results of their students and all these results should be moderated by the College before the results are sent to the ICT unit. Senate directed that only the Dean, of the College is the only person that could edit any result with the permission of the HOD concerned.

#### 9. ICAN CERTIFICATION

Senate was informed that in 2012 the University being found worthy was granted a certificate of exemption in certain courses in the Accounting Programme. The University have been informed that a renewal certificate is ready for collection on 6<sup>th</sup> April, 2018 in Lagos, Senate therefore approved that the Vice-Chancellor in the company of the Bursar, the Dean, College of Management and Social Sciences and the HOD Accounting and Finance department should pick up the certificate.

### 10. MEDICAL LABORATORY PROGRAMME

Senate noted with pleasure the report of the Committee on the establishment of Medical Laboratory Programme in the University and for the Programme to commence in the 2017/2018 academic session a Committee was set up by Senate to look into the NUC BMAS of the Programme and come up with a curriculum for implementation. # 14. STAFF WELFARE SCHEME

Senate was not impressed about the quality of the presentation of the report and observed that in the report only staffs that have experienced some sort of calamity or unpleasant circumstance were taken care of only. The report was rejected and the Committee was directed to represent to take care for all situations.

## 15. DIPLOMA PROGRAMME

Senate constituted a Committee to look into the commencement of a Diploma programme that could cater for the needs of religious leaders and the Community at large. The Committee was saddled with the responsibility of designing a Curriculum, Fees and Personnel. The membership includes:
