

DECISION EXTRACTS OF 88TH MEETING OF SENATE HELD ON THURSDAY 18TH JULY, 2019 IN THE SENATE CHAMBER, SENATE BUILDING, FOUNTAIN UNIVERSITY CAMPUS, OSOGBO

1.0 Report of the Committee on the Use of Result Processing Packages

Dr. A.J.K Shittu to be invited to present the report at the next meeting of Senate slated for 30th July, 2019.

2.0 Report of the Committee on Establishment of Entrepreneurial Skill Development Centre

The Curriculum Committee to consider the proposed curriculum of the Entrepreneurial and Skill acquisition programme (GSE). Final report to be presented by Prof. A. Usman at next meeting of Senate.

3.0 Report of the Committee on Review of Students Handbook

Dr. Muse Oke to present the report of the Committee at the next meeting of Senate.

4.0 Report of the Committee on Requirements for Admitting Candidates with OND/NCE into the University Programmes

All those coming in with OND/NCE certificates were to obtain the Direct Entry Form. They must not be admitted for the Conversion programme.

5.0. Report on Second Semester Admission

A 2-man Committee comprising of **Professors A. Usman and Goke Lalude** to come up with modalities and present a report at the next Senate.

6.0 Request for Correction of Second Semester 2017/2018 Session for level Biochemistry and Nutrition.

Senate granted the request to change the class of degree of DADA, Felix Abayomi (NAS/16/0113) from Second Class Honours (Lower Division) to Second Class Honours (Upper Division) and directed the HOD, Chemical Sciences to reflect the new class of Degree.

7.0 Amendment to 2018/2019 First Semester Result: Mass Communication (400 level & 300 level Part Time).

The HOD, Mass Communication to take the amended result to the Business Committee of Senate (BCOS) and bring to Senate for consideration.

8.0 Consideration of Amended 2018/2019 Academic Calendar

Senate approved the calendar subject to correction that change in date for the mid-semester break. The amended calendar to be circulated.

9.0 Inclusion of Conversion Students for the purchase of Memorabilia in 2019/2020:

Senate approved the proposal that Conversion and PG students to pay for the University's memorabilia and the fee should be included in the prescribed fees on the admission letter with effect from the 2019/2020 academic session.

10.0 Review and Consideration of the Reports of Student Disciplinary Cases:

a. SDC report of 4th April, 2019
Senate adopted recommendations of the SDC on the panel held on 4th April, 2019 that LAWAL Fuhad be expelled while ATOBAJEUN Sekinat Kofoworola to undergo rehabilitation and undertaking to be of good behaviour.

b. SDC report of 20th May, 2019
Senate adopted recommendations of the SDC on the panel held on 20th May, 2019 that all of them except OJO Michael should be given a second chance and to be on two weeks community service. Mr. Azeez Abdulkakeem should oversee the activities to ensure total compliance. They should be given a certificate of completion of community service and upon completion and their pictures put on the website, notice boards and platforms as deterrent.

In addition, Senate also resolved that all first-time offenders who have either being^f expelled or suspended during the session should undergo rehabilitation and if given a clean bill of health, they should be readmitted back to the University after a letter of undertaking.

c. SDC report of 31st May, 2019
Senate adopted the recommendations of the SDC on the panel held on 4th April, 2019 that OJO Michael Toluwalase should go through rehabilitation like others that were given a second chance.

d. SDC report of 11th June, 2019
Senate adopted the report of the SDC of 11th June, 2019 that all involved should be on two week's community service. A data base of all cases considered by the SDC should be compiled by the SDC with background and detailed information of erring students.

e. SDC report of 1st July, 2019
Senate considered the report of the Committee on the panel held on 1st July, 2019 and modified the recommendations as follows:

- i. In the case of Assault of SHITTU Adams by LAWAL Fuhad and ADEGBITE Jimoh Adeola. LAWAL Fuhad and ADEGBITE Jimoh A. to be **RUSTICATED** for 2019/2020 session.
- ii. In the case of Couriers of Indian Hemp involving YUSUF, Abdulkakeem Olamilekan and UMAR, Faruk, both 400 level students of Computer Science, they should both be **SUSPENDED** for 1st semester of 2019/2020 academic session.
- iii. In the case of assault of ABDULAZEEZ Shukurah, 400 level Economics by ALATE, Ibrahim, a 400 level Business Administration student. ALATE Ibrahim should be **SUSPENDED FOR ONE SEMESTER** in 2019/2020 academic session.
- iv. In the case of cigarette smoking by GIWA, Munirat, a 200 level Political Science Student, she is to **UNDERGO REHABILITATION** and the parent to be invited to a meeting in the first week of August, 2019.
- v. In the case of four Mass Communication Students caught for examination malpractice, ARANSEOLUWA Kaosara Opeyemi 200 level (FUO.17-00112), ABDULAZEEZ, Salim Malik 200 level (FUO/170009) and GARUBA Sodiq 300 level (FUO/16/0279) should be **SUSPENDED FOR ONE SEMESTER** in 2019/2020 academic session. ADESINA Fuhad Oluwajuwon 300 level (NAS/15015) to be **RUSTICATED** for 2019/2020 session.
- vi. That ADEGBITE, Jumah a 100 level Accounting student and LAWAL, Fuhad a 300 level Accounting student should be **RUSTICATED** for 2019/2020 academic session.
- vii. Case of Assault on a Female student by Mrs. B. Abdulsalami. Senate decided that a letter of apology should be sent to the parents of the student.

11.0 Cases of Pregnancy, Substance Abuse and University Extant Laws

Senate resolved as follow:

- i. that the student Handbook should be reviewed to capture issues of pregnancy among female students on campus.
- ii. that pregnancy test should come up randomly.
- iii. that in case any female student tests positive, parents should be invited and requested to organize a marriage immediately otherwise she would be asked to leave the University.

Senate noted that the Management has directed the team to visit the building released by the Aragbiji and assess it to know what to put in place. A Psychologist, Counsellor and Imam have been invited for the rehabilitation planned during the long vacation to rehabilitate students recommended for rehabilitation.

Senate resolved that any additional fact that can improve the University’s Condition of Service should be incorporated before Council’s approval.

17.0 Progress Report on Lectures Monitoring for the Second Semester of the 2018/2019 Academic Session, 4th July, 2019

Senate directed that monitoring of lectures to also be extended to cover the Conversion Programme.

A standing Committee on verification of certificates was constituted as follow:


