

DECISION EXTRACTS OF 92nd STATUTORY MEETING OF SENATE HELD ON TUESDAY 5TH NOVEMBER, 2019

1.0 Matters Arising from Previous Minutes:

- i. **Min. 866.3 Certificate Screening Committee**
Senate approved the nomination of Mr. R.O. Garuba as replacement for Dr. F. Raji who is currently on Post-Doctoral Leave.
- ii. **Min. 872.0 Illegal Writing of Examination:** AJANI, Ibrahim Abayomi (MAS/14027) 400 Level Political Science
Senate resolved that the parents of AJANI, Ibrahim be given three (3) more weeks, lapsing on the 26th November, 2019 to settle the outstanding fees of their son.
- iii. **Min. 904.0 Representation of University Librarian**
Senate resolved that Mr. S. F. Bakrin should henceforth represent the University Library at Senate whenever the need arises.
- iv. **Min. 907.0 Appointment of Heads of Departments/Coordinators**
Senate directed that the name of Mr. I.A. Badmus should be included on the list as the Coordinator, GNS Unit and Dr. S. Osineye should be retained as the SIWES Coordinator.

2.0 Upload of Updated CVs and course-wares for 2019/2020 Academic Session

Senate directed that all academic staff members should upload their updated CVs including publications as well as course-wares for the 2019/2020 academic session not later than Friday, 8 November, 2019 to improve the visibility and webometric standing of the University.

3.0 Penalty for Late Registration

Senate directed that Bursary should remind HODs and Level Advisers the effective week for the commencement of late registration for returning students and the approved fine.

4.0 Requirement for Conversion Programme

Senate reaffirmed that only HND holders are qualified for the 300L Conversion programme; ND/NCE holders should apply through JAMB Direct Entry to qualify for admission into 200 Level ONLY. Those wrongly admitted should have the admission withdrawn IMMEDIATELY.

5.0 Consideration of the Revised Student Handbook: Amendments

The following were approved for inclusion:

- a. **Pregnant Students**
Any student who gets pregnant during the course of her study would forfeit the right of stay in the Hall of Residence until deliverer of the baby.

b. Student Caught with Charm

Any student found to be in possession of charm or any illegal item shall be guilty of misconduct and his studentship summarily suspended, pending investigation by the Student Disciplinary Committee (SDC).

e. Campus Security

Unannounced periodic checks should henceforth be carried out in Hall of Residence to improve the security system.

6.0 Constraints in fulfillment of financial obligations

Any student who has some difficulty in paying the prescribed tuition fees etc should relate with his/her HOD not later than two (2) weeks before the examination and not at the point of writing examinations.

Senate directed that:


- i. **Bulk SMS messages** should be sent to parents of graduating students on the requirements,
