Dissertation/Thesis (Starting with the highest) in CV Listing

Degree title and Discipline, Date, Title of dissertation/thesis (in smart quotes), Institution

Example:

Ph.D. History 1992, "The 'Ulama of Borno: a Study of the Relations between Scholars and the State under the Sayfawa, 1470-1808", Northwestern University, USA. (Please note that the first letter of every key word of the title is in cap).

Books

Author (s), Surname (in CAP), Middle name (initial), First name, year (in bracket), title, (in italic, first letter of every key word in cap), volume (s) &/ edition (if applicable), place of publication: publisher.

Examples

ARIBISALA, B. Samuel (2008), Comparative Analysis of Methods of Solving Non-Linear Equations, New York: Elsevier

ARIBISALA, S. Benjamin and CLARIDGE, Ela (2010), "Computing Irregularity for Features in Medical Images: A Case Study of Malignant Melanoma, A Skin Cancer" Germany: LAP LAMBERT Academic Publishing.

Chapter in Book

Author (s), Surname (in CAP), Middle name (initial), First name, year (in bracket), title of chapter (in smart quotes), page(s), in book title, editor(s), place of publication: publishers.

Example:

BEESTON, B. Alfred (1983), "The Role of Parallelism in Arabic Prose", 180-85, in *Cambridge History of Arabic Literature, vol. 1: Arabic Literature to the End of the Umayyad Period*, edited by Alfred B. Beeston, Raymond B. Serjeant, and Gray B. Smith, Cambridge: Cambridge University Press.

Encyclopaedia Entry

Author (s), Surname (in CAP), Middle name (initial), First name, year (in bracket), title of entry (in smart quotes), title of encyclopaedia (in Italic), volume (in Roman numeral), page(s).

Example:

VIRE, M. Fredrick (1999), "Zarafa", Encyclopaedia of Islam, New Edition, XI, 457-58.

Journal Article

Author (s), Surname (in CAP), Middle name (initial), First name, year (in bracket), title of article (in smart quotes), title of Journal, Volume and Issue/Part (if applicable), page(s), DOI (Document Object Identification -if applicable)

Example:

SANNI, O. Amidu (1999a), "Recomposition: an Aspect of Arabic Literary Theory", *Islamic Culture*, 73, no. 4, 105-20.

SANNI, O. Amidu (1999b), "The Authority of Tradition and the Tradition of Authority: On Innovation and Imitation in Arabic and Early Classical Theoretical Discourse", *Journal of Oriental and African Studies*, 10, 19-51.

Referred Conference Proceedings/Abstract Volume

Author (s), Surname (in CAP), Middle name (initial), First name, year (in bracket), title of contribution in the Proceedings (in smart quotes), page(s), in full title of the Proceedings, editor(s) (if any) place of publication: publishers.

Example:

SANNI, O. Amidu (1989) "From Value Judgment to Theoretical Formalism: the Development of Arabic Theory on *Sariqa* (Plagiarism)", 384-94, *Proceedings of the 1989 International Conference on Europe and Middle East*, Durham: British Society for Middle Eastern Studies.

Review Essay/Article

Author (s), Surname (in CAP), Middle name (initial), First name, year (in bracket), title of review article (in smart quotes), title of Journal (in Italic), Volume and Number/Part (if applicable), page(s), DOI (Document Object Identification -if available).

Example:

Güçlu, F. Yücel (2015), "Eugene Rogan, *The Fall of the Ottoman: The Great War in the Middle East, 1914-1920*", *Journal of Muslim Minority Affairs*, 35, no 4, 580-88.

Book Review

Author (s), Surname (in CAP), Middle name (initial), First name, year (in bracket), title of review article (in smart quotes), title of Journal (in Italic), Volume and Issue/Part (if applicable), page(s), DOI (Document Object Identification -if applicable).

Example:

FAJONYOMI, S. Olubanji (1997), "Africa's Management in the 1990's: Reconciling Indigenous and Transplanted Institutions by Mamadou Dia" *The Journal of Modern African Studies*, 35 no.4,753-55.

Publications (accepted but yet to appear)

Author (s), Surname (in CAP), Middle name (initial), First name, year (in bracket), title (in smart quotes), (other coordinates).
